Commercial Contract for Outdoor Space Rental

(Special - 50 feet & over)

September 1 to September 4, 2011

Space is rented at a cost of \$5.00 per foot, based on the number of feet of frontage required. Any special requirements (i.e. hydro hook-up, desired location etc.) must be specified. Outside food vendors will be required to pay a \$25.00 garbage fee. All food vendors will be inspected by the Niagara Regional Health Department before and/or during operation. Any vendor using propane equipment must show valid proof of inspection or pay \$50.00 to have all related equipment inspected by an authorized propane inspector appointed by the Smithville Agricultural Society before operating their equipment. Any necessary repairs or adjustments are the financial responsibility of the vendor.

PLEASE NOTE *** 13% HST must be added to all rental, garbage & inspection fees*******

Rental space is booked for the entire duration of the Fair as follows: Thursday 4:00 p.m. to 10:00 p.m.; Friday 10:00 a.m. to 10:00 p.m.; Saturday 9:00 a.m. to 10:00 p.m. and Sunday 10:00 a.m. to 6:00 p.m. Booths may be set up beginning at noon on August 31st or any time during the day on September 1st. Booths must be ready to open on Thursday at 4:00 p.m. Upon receipt of full payment for your rented space, you will receive one VENDOR ribbon for each \$50.00 you have paid in space rental fees. Each ribbon allows 1 person unlimited access to the Fairgrounds. Any additional ribbons needed for yourself or your helpers must be purchased prior to the start of the Fair for \$18.00 each, or regular single admission of \$7.00 may be paid by your helpers at the gate. You may also purchase single gate passes for your helpers for \$7.00. Please note that it is the **responsibility of the vendor** to see that all helpers have appropriate ribbons or passes with them in order to gain entry to the Fairgrounds or they **will be charged admission**.
